- I. To provide up to \$250,000 from the Defence Fund to resource a campaign for the 2011 provincial election. (June 16/17, 2011)

That FPSE will work to build opposition to Bill 18 by working in solidarity with other post-secondary education unions, the broader labour movement in BC and across Canada to denounce the injustice of this legislative attack on the rights of our members to participate fully in the governance of their local institution. 6. That FPSE Presidents' Council fund a full-time release for six months of up to \$25,000 for one ETEA member, who has direct experience in the ETEA organizing drive, to organize unorganized schools; and

That Presidents' Council recommend that the organizing budget line be increased to \$40,000 for 2012/13 to purchase release time for a full-time organizer from Local 21 for six months.
